- 3. New Member Introductions -- None
- 4. New Business
  - a. Charity Check Presentation—Monika King Lori and Paul thanked all for the work of the charity committee and the Club for participation. Christina Walker provided information on Third District Guardian Ad Litem. The charity serves the 3<sup>rd</sup> Judicial District and advocates for about 700 child victims of abuse and neglect. Majority of advocates are trained community volunteers. Currently have 86 volunteers and need another 50 volunteers. Participants average 2 hours per week after initial training program. Incidence of child abuse has been

increasing during the pandemic and with issues of online school which may slow down reports of abuse. Christina advised a child with a guardian is half as likely to be abused again and 8 times more likely to graduate from high school, and half as likely to have any contact with law enforcement. Differences can extend thru their entire life.
