## Minutes January 11, 2022 In person Porsche Boise

- Meeting Called to order at 6:28 p.m.
- Introductions
  - First time attending members Rick Prescott (Test Drive seeking new 911) and Britteny Stevenson (Panamera 4S) were introduced
- Director and Chair Reports
  - President Report—Andrew King
    - Lindsey Robinson completed Past President Report and Continuity checklist and new officers recognized by PCA National
    - Initial calendar of member events completed, Ken Robinson will manage the calendar
    - Created list of Special Projects for Board including:
      - Governance/Administrative
      - Refresh or update SSPCA processes, activities, infrastructure
      - Identify new/renewed member events and activities
  - Treasurer Report—Gary Roeder
    - Completing review of prior year financial data; year end balances are strong:
      - \$17,462 in CD's and \$15,113 in checking with no significant liabilities except the publishing of the latest Sage Tick
      - CDs at maturing and Board agreed to merge CDs into one maintaining reasonable reserves at a higher interest rate
  - Secretary report—Andrew King for Sharon Fergot
    - Looking at options for storage and archiving solutions for historical documents
  - Membership Report—Laura Outlaw
    - As of December 2021, SSPCA has 432 Primary members, 235 Affiliate Members, Total membership 667
    - 10 new members, 2 transferred in, 1 transferred out, 9 lapsed
    - Andrew discussed opportunity to explore increasing co-memberships
- Upcoming Member Events

- Tech Sessions—Andrew King
  - Early February Tech Session at Porsche Boise will cover insights regarding the dealership, new car allocations and dealer service and accessories
  - Early March Tech Session at Lupo Motors including tour of their new facility and market evaluation update with insight from Scottsdale auctions
- Special Projects
  - Articles of Incorporation (AOI)—Gary Roeder
    - Existing AOIs are outdated (circa 1967) and in conflict with current and future Bylaws and a restatement is required
    - AOI's were updated and ready for filing as a 501 (c) (7) nonprofit in compliance with current Idaho Law
  - Updated Bylaws—Andrew King
    - Current Bylaws are from June 2015, Board is reviewing and updating based on current PCA template
    - Once finalized, Bylaws will be distributed to membership for review and voting with final version submitted to PCA National for endorsement
    - Plan to distribute draft revision prior to next Board meeting
  - 2022 Financial Operating Plan—Gary Roeder
    - Completing review of financials to provide Financial Report for 2021 and 2022 Planning Budget
  - 2022 Event Registration—Bob Pentecost
    - Constant Contact is charging transaction fees above the PayPal fee; event organizers will need to account for additional fees.
    - Current plan is to use Constant Contact partner, WePay, which will charge 5.4% + 80 cents of each transaction; members will not need any special WePay account or login
    - Event coordinators will need to account for this WePay fee in their event planning
    - Will explore use of Motorsport.reg
  - Silver Sage Records—Andrew King
    - Board is reviewing method to retain historical and current club records electronically including possible solutions through PCA National.
  - Website Refresh—Andrew King
    - Silver Sage website needs to be refreshed to address outdated information, effective linkage to social media, etc. Club needs a volunteer from the membership to assist as webmaster.

- o New Business
  - Monthly Membership Meeting will now be held on the 2<sup>nd</sup> Tuesday of the month
  - Porsche Parade 2022 Phase I Registration opens February 2<sup>nd</sup> at 10 a.m.
